The exhibitor will not be allowed to occupy or assemble his stand should the payments corresponding to the booking of space or other complementary services not be settled on deadlines.

## Regulations extract

### Space reservation

Up-front payment of 50% must have been settled to guarantee space award. Failure to comply with the established payment terms shall entail forfeiture of all rights and amounts paid for space reservation. In the event that an exhibitor cancels space reservation, he shall forfeit all amounts submitted to that date. Open Events Group S.L. ( hereinafter the Organisation) shall inform the exhibitor in writing of such circumstances. Reserved or contracted spaces cannot be transferred, be it in the whole or in part to other firms, unless previously authorised by the Organisation. During the event, the exhibitor shall use exclusively the contracted space to display his goods and he will under no circumstances be allowed to use any other spaces to display or install any goods, services, etc. Repeated failure to observe these rules will cause the closing down of the stand.

### Assembly and disassembly

Assembly of the stands and setting up will be carried out on the days fixed by the Organisation. Disassembly will be done on closure day, and if authorised, may be extended to the following day. All amounts corresponding to services hired, must be settled before closure. Should there be any outstanding payments (such electrical consumption, furniture, etc.) the Organisation can and will impede the dismantling of the stand. Exhibitors will always act with diligence and due respect to other exhibitors, visitors and Organisation, and will be responsible for any damage or harm that such lack of proceeding might cause to third parties.

### Compulsory insurance

Pursuant to Fira de Barcelona requirements, public liability and property damage insurances are compulsory. All exhibitors participating in the Event adhere to policies currently in force, underwritten by the Organisation, when signing the registration form. Insurance cover is detailed in exhibitor folder to be delivered.

### Advertising, photography and audiovisuals

Any advertising or promotional activities carried out beyond the limits of the exhibitor's stand are strictly forbidden. The Organisation reserves the rights to take photographs, film all demonstrations held at stands, stages and around the enclosed area, and to publish them in any media it deems appropriate.

### Supplementary services

Supplementary services, such as vigilance, electrical panels and power, counters, furniture, etc. are delivered by SERVIFIRA. An exhibitor's form will be delivered in time with all contracting forms.

### Admission Rights

In the event of any dispute, the Organisation may request the exhibitor the original documentation granting the rights of distribution of the goods in display. Should the exhibitor be unable to provide such documentation, and the original distributor lodges an official complaint, the Organisation may request the removal of the goods involved, or if the case, seal the stand.

It is not allowed to use any type of advertising or promotional activity which implies competition with the Event. The Organisation has the right to admit firms and individuals to the event.

### Acceptance of regulations

By signing the registration form, the exhibitor expressly and unconditionally accepts the terms and conditions to participate in the Barcelona Harley Days Event.

### Disputes and litigation

Both parties, Exhibitor and Organisation agree within this form, that all disputes that might arise from or in connection with the Event will be settled by the Court of Barcelona, in Spain
